Our Company sought a sum of ₹ 41.87 Crore (including applicable interest till the date of filling of the statement of claim) for, among others, loss suffered due to underutilisation of plant and machinery for reasons attributable to the Respondent and loss due to non-payment of amounts as per market rates.	Amount awarded by Arbitral Tribunal in favor of the Company: Rs. 6.50 Cr. + future interest @12% per annum simple interest from the date of publish of award i.e. 27 th September 2021 to the date of actual payment of award amount. No future interest is payable to the claimant in case the respondent makes the payment of award amount within 90 days from the date of publish of award.
