### 1. Purpose

GRIL maintains an Environmental Management System (EMS) that serves as a framework to achieve the following commitments:
  - Communicate this Policy and program initiatives to team members and other stakeholders.
  - Conduct business in an environmentally responsible manner and seek ways to reduce the impact
    of our facilities and operations on the environment, with a focus on reducing pollution, reusing
    and recycling waste and take initiatives towards efficient use of natural resources.
  - Ensure positive legal compliance with all relevant environmental laws and regulations in which GRIL operates.
  - Continuously improve GRIL's environmental performance of current and future projects by measuring significant impacts, setting realistic targets for improvement and monitoring progress.
  - Develop, implement, and maintain standards and procedures for reviewing, assessing, and managing the environmental risks as well as promoting sound environmental management practices among those with whom business is conducted in accordance with ISO-14001:2015 Standards.
  - Proactively seek and consider stakeholders' perspectives on environmental issues and priorities.
  - Educate, motivate, and enable team members to conduct their employment activities in an environmentally responsible manner.
  - Enhance environmental awareness through participation and consultation with employees and contractors by training and effective channels of communication.
  - Integrate environmental considerations into procurement activities and seek to form business relationships with third parties and sub-contractors.
