- 1 The above standalone unaudited financial results of Porbandar Dwarka Expressway Private Limited ("the Company") are prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard ("Ind AS") 34 on 'Interim financial reporting' prescribed under Section 133 of the Indian Companies Act, 2013 read with the relevant rules issued thereunder and the other accounting principles generally accepted in India. These standalone unaudited financial results have been prepared for the limited purpose of inclusion in the consolidated unaudited financial results of the parent company viz. G R Infraprojects Limited for the quarter and nine month ended December 31, 2023. These financial results have been approved by the Board of Directors in their meetings held on February 2, 2024.
- 2 The Company is primarily engaged in the construction business, which in the context of Ind AS 108, Operating Segments is considered to be its only reportable business segment. The Company operates in India only and hence, there is no reportable geographical segment.
- 3 The figures for the quarter ended 31 December 2023 and 31 December 2022 are the balancing figures between figures in respect of nine month ended 31 December 2023 and 31 December 2022 respectively and the figures for the half year ended 30 September 2023 and 30 September 2022 respectively.
