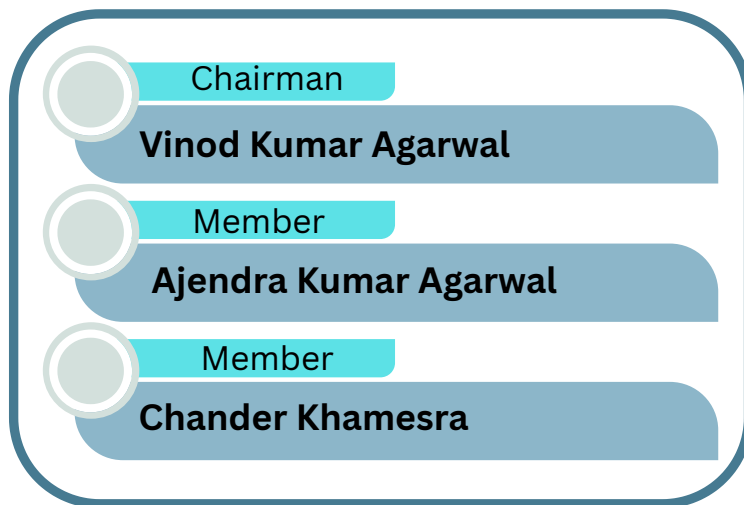

# **Methodology for Impact Assessment**

# Methodology for Impact Assessment

## Scope of the Study

G R Infraprojects Limited has initiated a wide range of CSR projects as part of its commitment to contribute back to the community. Over the years, it has undertaken CSR projects under the themes of Education, Healthcare, Environment, Women Empowerment and Sports. In line with its CSR commitment, GRIL approached Incorp Advisory Private Limited to independently assess and review its projects. As part of the assessment, the Inclusiveness, Relevance, Efficiency, Convergence and Sustainability framework (IRECS) was considered as the basis for evaluation. Recommendations on the project performance was then provided to the Management for its evaluation and consideration.

The scope of the CSR assessment included the following activities:

- Understanding scope of the CSR assessment to be carried out and the assistance to be provided.
- Conducting a desk review of the relevant documents of the projects provided by the company or its social arm G R Infra Social Welfare Trust.
- Identifying key stakeholders impacted by the projects for consideration in research and assessment.
- Developing quantitative and qualitative assessment questionnaire to be used with concerned stakeholders, project owners, and project participants to obtain project insights.
- As per the relevance of the project and project steps, considering a quantitative sample survey of beneficiaries.
- Data collection through virtual interactions based on the questionnaires developed and consultation done.
- Conducting analysis of the information and assessment of outcome/impact based on IRECS framework.
- Developing a report based on the findings, analysis and recommendations for management consideration.

## Detailed Methodology

To assess the impact of the projects as mentioned in Table 1, the following detailed steps were undertaken by the project assessment team. This enabled the team to quantitatively and qualitatively assess the impact of the projects on the lives of the beneficiaries and the stakeholders.



## Engagement Kick-Off & Finalization of Scope

The impact assessment was initiated with a kick-off meeting wherein the project owners from GRIL and Incorp came together for a high-level discussion on the scope and steps involved in the assessment. GRIL was requested to share all the relevant documents pertaining to the projects being assessed.

## Desk Review & Stakeholder Consultation

Once the scope was finalized and the steps involved in the assessment were well understood by GRIL, a thorough document review was undertaken by the assessment team. The gaps in documentation were identified and conveyed to the project owners at GRIL. Meetings were conducted with the internal stakeholders of the projects to get a complete overview and understanding of the projects.

## Questionnaire and Survey Research Tools

After assessing available documentation and internal stakeholder consultation, the research team developed tools such as project specific questionnaire and beneficiary survey to further determine qualitative and quantitative aspects of the project as required under the IRECS framework. The IRECS framework is a basic project assessment guideline and can be used for a wide range of CSR projects. The framework has five main categories of qualitative assessment to determine impact created, stakeholder perception, extent of collaboration with other stakeholders and sustenance of the change.

### **Inclusiveness (I)**

To what extent have all stakeholders, especially the most disadvantaged and underrepresented been able to access the benefits and actively participate in the institutions and processes created through the project, ensuring fair and equitable distribution of resources and outcomes?



## ➤ **Relevance (R)**

Do the services, resources, and institutions supported by the project align with the actual needs and priorities of the local community? Was the planning process inclusive and participatory? Were success indicators developed collaboratively, incorporating community input?

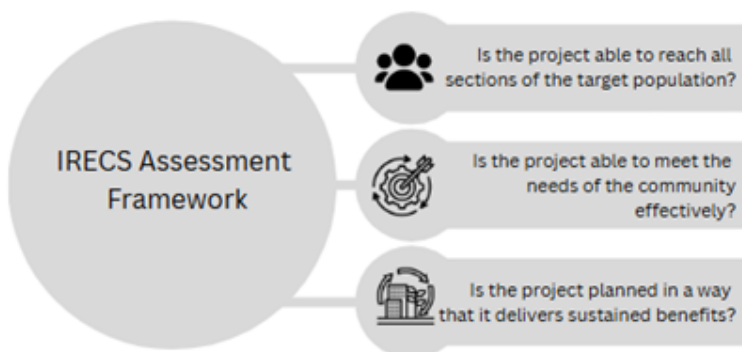
## ➤ **Effectiveness (E)**

How well have the project activities fulfilled the expectations of the community? Were the interventions completed on schedule and within budget? Have resources been allocated, tracked, and utilized efficiently? Is the model scalable or adaptable for implementation in other regions?

## ➤ **Convergence (C)**

How effectively has the project aligned and integrated with existing government schemes or other collaborative initiatives? What is the nature and strength of the connections between individuals, communities, institutions, and external stakeholders?

## ➤ **Sustainability (S)**



Is there a sense of community ownership over the outcomes and assets created? Are the interventions likely to continue delivering benefits post project-completion, independent of donor support? Have local institutions been equipped to maintain these outcomes, and is there a defined strategy for project exit?

## ➤ **Data Collection, Analysis & Recommendation**

Since the scope did not involve on-field data collection, our project team collected data virtually and analysis was carried out to arrive at insightful findings for each of the projects. The draft report was prepared and shared with GRIL and GR Infra Social Welfare Trust for their inputs and feedback. The final report was then submitted to GRIL management for consideration of inputs and recommendations.

## Background



Sahawa is a village in the Taranagar sub-district of Churu district in Rajasthan, India. GRIL has long been associated with the people of Churu by means of its various educational, health care and animal welfare associations. By regular interactions with the village folk, GRIL personnel were aware that a lacuna was felt by the villagers when it came to higher educational facilities and employment opportunities.

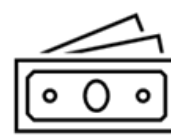
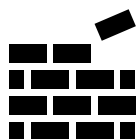
## About the Project

Sahawa village has a population of 14,841 individuals as per census of 2011<sup>1</sup>. Churu district had population of 2,039,547 of which male and female were 1,051,446 and 988,101 respectively as per Census 2011<sup>2</sup>. While Sahawa had government run primary, secondary and senior secondary schools, they did not have a government undergraduate college. Village students, after completion of higher secondary grade had the option of joining nearby private undergraduate colleges but many could not afford the fees of private colleges and hence dropped out. Girl students often lost out on higher education as villagers did not approve of the high fees and long distances to private colleges. To address these issues, GRIL, as part of its CSR initiatives, embarked on an infrastructure project to construct a college in collaboration with the local government. The project was delivered through its social arm, G R Infra Social Welfare Trust. Smt. Mohani Devi Chachan Government College co-educational college was established in 2021 and construction was completed in December, 2023. The college started offering free undergraduate courses under the ambit of Government of Rajasthan, Higher & Technical Education from the academic year 2024-25.

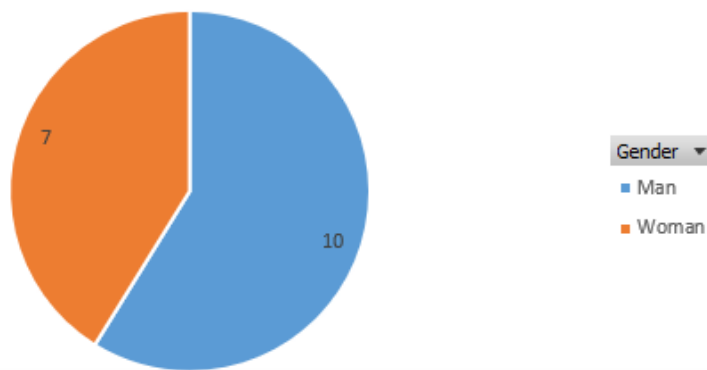
## Assessment Methodology, Analysis & Findings

After a desk review of documents shared and initial internal stakeholder consultation, a beneficiary survey was floated to further assess the impact of the project. Out of the 458 total beneficiaries so far, 17 beneficiaries responded to the survey. This represents roughly 4% of the total beneficiaries. In addition to the sample survey, the assessment team conducted an interview with the acting principal of the college.

From the qualitative and quantitative assessments, consultations and surveys; the following are the notable inferences and assessments from which the final recommendations are made.

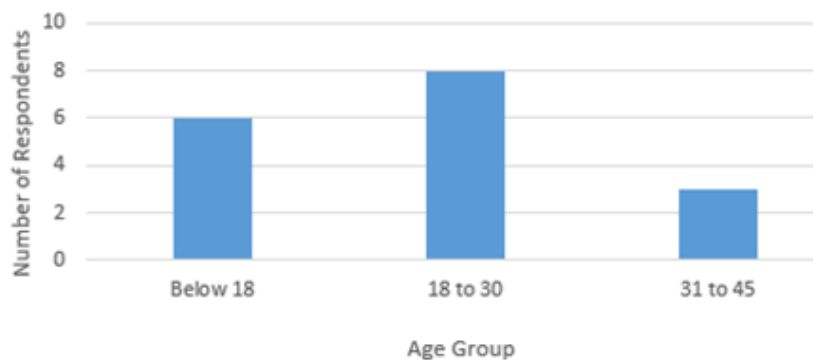
- Profile of Respondents of Survey

Gender Distribution of Respondents



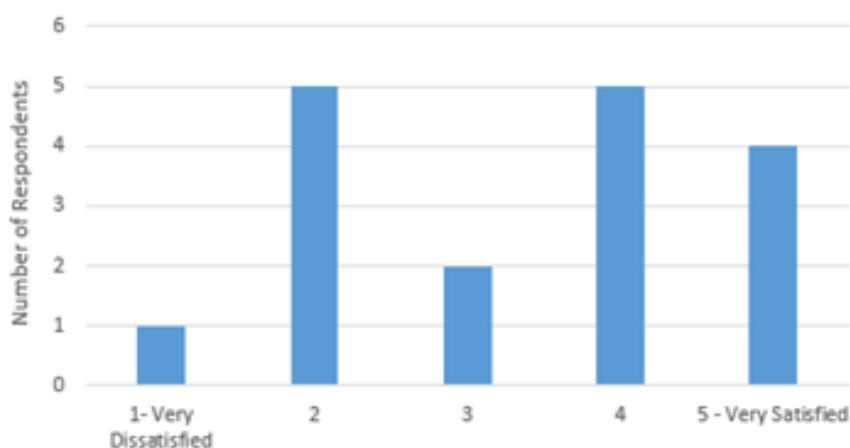
- Age group of the Survey Respondents

- The occupations of the respondents included students, farmers, self-employed, government employees and housewives.
- Almost all the respondents have benefited from the project for more than 1 year.
- More than 50% of respondents expressed satisfaction with the current project while most of them agreed that the project will play a positive role in the coming days (long-term impact).

- Furthermore, almost all the survey respondents believe the college will impact their income and employment opportunities positively. Nearly 40% perceive a highly positive impact on their income and job opportunities.
- The survey respondents agree unanimously that lack of job opportunities remains the key concern even for those who are passing out of the college as graduates.
- The respondents believe that the following will improve the functioning of the college further:
  - (a) Educated Staff and Teachers for all subjects
  - (b) Well Equipped Library for B.A related course books
  - (c) Training for Professional and Competitive Exams
  - (d) Playground
  - (e) Security Cameras

## IRECS Analysis

### Inclusivity

By incorporating a variety of consultation methods, GRIL was able to ensure that the project was both inclusive and responsive to the local community. The goals of the project were well aligned with the community's needs, minimized conflicts, and fostered a sense of ownership and support from all parties involved. Vulnerable groups such as low-income families, people with disabilities, minorities were also considered in project planning to provide equal access to all. The Company has ensured proper facilities and comfort for differently abled students, women, and those coming from rural backgrounds, so that the college is inclusive and supportive for everyone.

A grievance redressal system has been put in place at the college to address concerns of students and staff, ensuring their feedback is heard and acted upon promptly.

From the survey, we can infer that while all the respondents belong to Churu district, they belong to different villages with Churu such as Sahawa, Baniyala, Punisar, Raiya Tunda and Somsisar. This provides an insight that the college has been inclusive in accepting admissions from across the district.

41% of the respondents are women and 59% are men.

They represent age groups between <18 to 45.

The beneficiaries belong to different occupational stages and profiles.

<b>Relevance</b>	<p>The initiative clearly addresses two pressing community issues: access to affordable higher education and employment opportunities in rural areas. A needs assessment was conducted before implementing the project to better align project goals with the needs of the community. By understanding the specific challenges faced by rural students and aligning educational and employment programs with local needs, the project aimed to create sustainable and meaningful opportunities for the community. This approach not only addressed the immediate needs of rural populations but also empowered them to build long-term solutions for their education and employment challenges.</p> <p>The project is well aligned with national educational goals of providing universal access to quality education, National Skill Development Mission and UN SDG Goal 4 (Quality Education). Further, the operation of the college is the agenda of the state education department, indicating a strong link with the education charter of the government.</p> <p>From the survey, it was clear that all the respondents have benefited from the project for a period of more than one year.</p>
<b>Effectiveness</b>	<p>The project was completed as per the planned timelines and within the allocated budget. No additional budget allocations were made during the project completion period.</p> <p>The beneficiary count and the diverse locations of the beneficiaries indicate that the project has effectively reached the student population of Sahawa and its nearby villages. The evidence from beneficiary surveys indicates proper functioning of the college and perceived long-term impact on education and employment opportunities for the students. More than 50% of the survey respondents have showed satisfaction with regards to the project.</p>
<b>Convergence</b>	<p>The partnership and collaboration between GRIL, GR Infra Social Welfare Trust and the local government has been fruitful as the needs of various stakeholders in this project have been successfully met. Since the government college free education, it is a preferred option compared to private colleges.</p>
<b>Sustainability</b>	<p>GR Infra Social Welfare Trust will be responsible for the ongoing maintenance of the project for a period of five years, ensuring its continued functionality, effectiveness, and long-term impact on the community. This commitment includes regular upkeep, monitoring, and necessary adjustments to maintain the project's success and sustainability over time. The college operations have been entrusted to the state government.</p>

## Recommendations and Way Forward

- **Leveraging Government Support:** The long-term success of the college will significantly depend on effectively tapping into government funding and policy initiatives to enhance student learning outcomes and strengthen the institution's academic infrastructure.
- **Fostering Strategic Partnerships:** Establishing collaborations with industry partners and complementary organizations can amplify the impact through initiatives like skill-building workshops, competitive examination training, interview & career guidance, industry site visits, internships, and volunteering programs.
- **Enhancing Skill Development:** GRIL can play a pivotal role in implementing targeted skill development programs for graduating students, with a focus on aligning training with immediate employment opportunities within GRIL's businesses and projects.
- **Establishing a Functional Library:** Developing dedicated library and reading spaces will promote a culture of academic inquiry and continuous learning, supporting students' research and educational needs in Arts stream.

- **Expanding Academic Offerings:** With well-established science laboratories, the college is positioned to broaden its academic portfolio by introducing B.Sc. programs, which can help attract a wider student base. Additionally, it can consider offering B.Ed to provide employment opportunities in teaching field and build local talent pool for schools in the region
- **Strengthening Campus Security:** Installing surveillance systems at key points across the campus will ensure the safety of both infrastructure and individuals, fostering a secure learning environment.
- **Sustained Engagement by GRIL:** Continued engagement by GRIL, in coordination with government stakeholders, will help maintain educational standards and institutional stability, ensuring lasting improvements in the quality of education delivered.

## Background






Baran is a southern district of Rajasthan with a population of 12 lakh as per Census 2011<sup>3</sup>. On 05 October 2001, a cow shelter called 'Shri Mahaveer Gaushala Kalyan Sansthan' was established for the welfare of cows. Shri Mahaveer Gaushala Kalyan Sansthan started serving orphan, unhealthy and unproductive cows primarily at three locations (Mamuni, Jaleda, Bada Balaji Dham). However, many cows, animals and birds (other than the cows sheltered) encountered fatal accidents, ill-treatment by humans, diseases and were often left to die without timely medical treatment.

## About the Project

The people of Rajasthan are known to be animal lovers. It is perhaps this instinct and objective to contribute to the cause of animal welfare and address the lack of emergency medical care for animals and birds that GRIL, as part of its CSR initiatives, embarked on an infrastructure project to construct a trauma care facility in the existing gaushala. The project was delivered through its social arm, G R Infra Social Welfare Trust. On 14<sup>th</sup> February 2023, with the contribution from GRIL, Shri Mahaveer Gaushala Kalyan Sansthan started a hospital for all animals in need of trauma care and emergency medical help. This initiative was called Shree Mahaveer Nishulk Pashu Pakshi Hospital Evam Mobile Trauma Center or (JEEVAASRA). This was a unique endeavor because of the high-tech medical diagnosis and treatment facilities, operation theaters, large & small OPD's and IPD's for ownerless, homeless street animals and birds. The treatment and facilities are provided to beneficiaries free of cost.

## Key Infrastructure Facilities:

- **State-of-the-Art Facility:** Jeevasra's trauma care center is a state-of-the-art facility, designed to support a wide range of diagnostic and treatment needs for animals and birds. It has three fully equipped operation theatres.
- **Indoor Patient Facilities (IPD):** The hospital offers unique indoor patient facilities specifically for animals requiring repeated dressings and ongoing treatment, ensuring comprehensive care for trauma cases.
- **Mobile Trauma Centre:** Jeevasra operates two 24-hr mobile trauma ambulances, enabling emergency treatment and surgical interventions at various locations, which is particularly valuable for rapid response to animal emergencies.
- **Free Medical Services:** All trauma care services, including emergency treatment, surgery, and consultations, are provided free of cost

## Key Infrastructure Facilities:

- **Advanced X-ray Room:** The center is equipped with a modern X-ray room featuring modern technology for precise diagnostic imaging, critical for trauma assessment and treatment planning
- **High-Tech Medical Diagnosis Equipment:** The trauma center boasts high-tech diagnostic and treatment equipment, supporting advanced medical interventions for animals and birds.

Apart from animal beneficiaries, it has provided employment to a team of veterinary doctors, nurses and caretakers. A total of 80 staff members are employed at Jeevasra.

## Assessment Methodology, Analysis & Findings

After a desk review of the project documents, website, beneficiary survey, social media pages of the aforementioned project (Jeevasra), a qualitative analysis based on the IRECS framework has been conducted by the assessment team.

The project's scope was strategically expanded to address community-identified needs, cultivating shared ownership among participants. By extending gaushala services to encompass all species (including birds) and providing trauma care irrespective of ownership status, the initiative demonstrates comprehensive inclusivity in service delivery.

## Recommendations and Way Forward

- **Sustained Financial Support:** Given that the Jeevasra initiative is entirely reliant on donations, GRIL's continued contribution through CSR funding—or by helping Jeevasra develop strategic avenues for ongoing financial support—is crucial to ensuring the program's long-term viability.
- **Advancing Veterinary Education:** Jeevasra holds potential to become a key player in veterinary training by forming partnerships with nearby veterinary colleges. Such collaboration would provide valuable practical experience for students and facilitate recruitment of skilled local professionals.
- **Deployment of Mobile Medical Units:** Introducing mobile medical units in rural areas would significantly enhance healthcare accessibility, especially in underserved and remote communities.
- **Enhanced Social-media and Digital Outreach:** Strengthening the hospital's presence on social media and digital platforms can significantly broaden its visibility and outreach. This not only enables the hospital to connect with more communities in need but also enhances opportunities for attracting donations and securing sustained funding support.



- **Structured Data Reporting:** It is advisable to establish a system for generating comprehensive reports on a quarterly or half-yearly basis. These reports should include:
  1. A detailed account of treatments administered, specifying the type of interventions, patient outcomes, and any follow-up care provided.
  2. An explanation of incomplete treatments, highlighting the reasons—such as medical complications, or resource limitations.
  3. Analysis of post-treatment survival rates and the success of rehabilitation or recovery efforts to assess long-term impact and treatment effectiveness.
