1	Brief details of litigation viz. name(s) of the opposing party, court/tribunal/agency where litigation is filed, brief details of dispute/litigation;	Opposing Party/Agency: Office of the Joint Commissioner of State Tax, Ratlam Division, Indore, Madhya Pradesh Brief Details: The Company has received a Show Cause Notice in Form GST DRC-01 dated August 25, 2026, issued by the Joint Commissioner of State Tax, Ratlam Division, Madhya Pradesh, under Section 74 of the CGST Act, 2017, for the tax period April 2020 to March 2021. The notice relates to certain GST-related discrepancies, including alleged excess/ineligible availment of input tax credit, mismatch in e-way bill and GSTR-3B data, and other related GST matters. The notice proposes an aggregate demand of Rs. 321.60 crore, comprising tax, interest and penalty.
2	Expected financial implications, if any, due to compensation, penalty etc.;	Since the matter is presently at the Show Cause Notice stage, the Company is in the process of preparing its response and firmly believes that it has strong legal and factual grounds to defend its position. The Company will take all necessary steps to present and defend its case before the relevant authorities. Accordingly, the Company does not presently anticipate any material financial impact or material liability arising from the proposed demand.
3	Quantum of claims, if any;	As per the Show Cause Notice, the proposed demand, including tax, interest and penalty, is Rs. 321.60 crore under Section 74 of the CGST Act, 2017 and the MPGST Act, 2017.
